October 2017 Financials

As regularly practiced, the board reviewed the October 2017 financial statements including the balance sheet, summary of revenue and expense statements, cash flow and check register. Kit Murley-Henspeter and Kara Schneeberger presented the November Finance Committee minutes and financial status updates. Cash flow is healthy and finances are stable. The Special Education and School Nutrition Program audits are in process.

FY 17 Financial Audit

Jim Eichten from Malloy, Montague, Karnowski, Radosevich & Co., P.A. (MMKR) presented the school's FY '17 financial audit.

MMKR issued an unmodified opinion on the school's annual financial statements.

MMKR reported the following:

- No deficiencies in the school's internal controls over financial reporting that were considered to be material weaknesses.
- The results of the testing disclosed no instances of noncompliance required to be reported.
- The Schedule of Expenditures of Federal Awards is fairly stated, in all material respects, in relation to the basic financial statements.

- The results of tests indicated that the Academy has complied, in all material respects, with the types of compliance requirements that could have a direct and material effect on each of its major federal programs.
- They reported no deficiencies in the Academy's internal controls over compliance that the firm considered to be material weaknesses with types of compliance requirements that could have a direct and material effect on each of its major federal programs.
- They reported no findings based on testing of the Academy's compliance with Minnesota laws and regulations.
