Kit Murley-Henspeter and Kara Schneeberger presented the finance report.

They discussed the FY17 \$740,000 that Indigo calculated as unallowable special education costs. This was submitted to MDE and MDE will take the funds back. The school will have deficit operations because of this in FY18. Because we are unsure how the state with take back the \$740,000, the school may need a line of credit. The board will be updated at the next meeting.

There are several impacts of this issue, including:

- -FY18 IEPs were all reviewed
- -The school may receive a penalty for FY17 since it did not meet Maintenance of effort due to the deduction of \$740,000 in expenditures.

The school will likely not meet its cash on hand and debt service coverage ratio because of the issue. Jen Geraghty will schedule a meeting with Indigo. The school is unclear yet on how state will take the money back.

Kit Murley- Henspeter presented a motion to direct Jennifer Geraghty to speak with the school's attorney, Laura Booth, to talk about the issue and to determine possible remedies. Motion was seconded by Virginia Anderson. Motion passed unanimously.

As regularly practiced, the board reviewed the March 2018 financial statements including the balance sheet, summary of revenue and expense statements, cash flow and check register. Kit Murley-Henspeter presented a motion to accept the March 2018 financials, March 20th Finance Committee Minutes and April 17th Finance Committee Minutes. Motion was seconded by Virginia Anderson. Motion passed unanimously.
