This amount will be recognized as a receivable in FY18 and will assist with cash-flow in FY19 as our bills will be lower.

The FY18 financial audit will be completed within the week.

The school will be offering extended day programing beginning in the fall of 2018. The school will offer this service in the morning and after school.

The school will not be receiving Title III funds in FY19 due to the decrease in EL students.

Jen Geraghty closely watched the food service operation fund each month and at year-end the food service fund ended in the black. This is the second year of positive operations.
